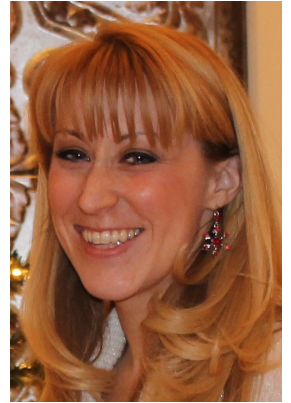


A Letter from Inland Valley Hope Partners' President

Dear Friends,

It's been several weeks now since the coronavirus drastically changed our way of life. While we all struggle with the uncertainty of these challenging times, there is one thing we at Inland Valley Hope Partners know for sure: **Our neighbors need us now more than ever!**

Hope Partners remains committed to supporting our low-income neighbors during the COVID-19 outbreak. Sadly, too many local families live in economic hardship, which means the loss of just one paycheck, or even one shift at work, may cause a dramatic decrease in financial stability, leading to food insecurity and jeopardizing their housing. Over the last few weeks, we have already experienced a sharp increase in the number of people seeking food assistance. **In fact, Sova and Beta, our two largest pantries, have been serving nearly double our normal number of clients daily.** We've also started seeing an uptick in the number of residents requesting rental and utility assistance to help them avoid homelessness and keep their water, electricity, and gas connected. We anticipate all these needs will continue to grow as the financial fall-out of the pandemic affects more and more families. If things continue this way for an extended period, we may soon experience a demand we haven't seen since the recession of 2008.



At the same time, we at Inland Valley Hope Partners are not immune to the uncertainty of this present time. In order to protect the health of our supporters, volunteers, staff, and clients, we recently made the difficult decision to postpone our annual Golf Classic to the next fiscal year. The "safer at home" order intended to slow the spread of the coronavirus is also impacting the finances of many local organizations, businesses, houses of worship, and individuals whom we depend upon for monetary support to keep our daily operations running. The sad fact is our financial resources are withering just as the need for our services is expanding. **As we stretch to meet the demand, we are requesting your support to help maintain our ability to carry out our mission to feed the hungry and shelter the homeless through this present crisis.** Your gift is critical in this challenging season to ensure our most vulnerable neighbors will have food to eat and a roof over their heads. Who We Are ...

Celebrating over 50 years of commitment, Inland Valley Hope Partners serves over 75,000 men, women and children each year through "Our House" family residential shelter; and Rapid Re-Housing; BETA, SOVA, Claremont, San Dimas and South Pomona food pantries; and the Pomona Farmers' Market throughout 13 communities including Chino, Chino Hills, Claremont, Diamond Bar, La Verne, Montclair, Mt. Baldy, Ontario, Pomona, Rancho Cucamonga, San Dimas, Upland, and Walnut. The shelter houses five families for up to 90 days. The food pantries distribute five days worth of food per person to no and low income families. Clients may come once every 30 days. The Farmers Market operates every Saturday morning and accepts WIC and EBT cards. Begun in 1968 as the Pomona Council of Churches, today the non-profit is a collaboration of faith communities, businesses, community groups, and individuals who care about their neighbors.

From the Front Lines: An Update From Our Food Security Program

Much like the local grocery stores, Inland Valley Hope Partners' food pantries experienced a huge rush of families and individuals seeking food and other essentials in the last two weeks of March. Our Food Security Program Manager Isaac Vega shares:

COVID-19 has certainly impacted our program: The pantries have had an increase of more than 1,000 additional people needing our services, but we have lost 90% of our regular volunteers due to the pandemic. We still have our pantry doors open but have had to adjust how we typically operate. Our Sova Center now only allows four people in the waiting room at a time with the required 6-foot distance between each of them while more clients are lined up outside. Meanwhile our Claremont, San Dimas and Urban Mission locations are only allowing one person inside at a time. It's been an adjustment, but everyone is handling it well.

Pantry staff and volunteers are also seeing many first time visitors to the pantries who are eager to share how the pandemic and the shut down of so many local businesses has affected their families financially. One first time visitor, Julio*, told us he heard about Inland Valley Hope Partners' food assistance from watching the news. Julio is a musician and the sole provider for his family. He had steady gigs lined up at local restaurants, bars, and clubs until the COVID-19 outbreak hit. Now he's lost his primary source of income and is feeling the stress of how he going to pay his bills and buy groceries for his family. He said it was a huge relief to learn that Hope Partners' Sova Food Pantry is located nearby and able to assist his family.

Sadly, Julio's story is not unique. His family makes up only four of the more than 4,600 persons Hope Partners provided food assistance to in the month of March. And, with the Labor Department reporting that more than 10 million Americans have recently filed for unemployment insurance in the United States, Isaac predicts that the number of people seeking assistance from our food pantries will continue to grow. "With a lot of people losing their jobs, we have had more first-timers coming in, and I expect there to be more coming in by the end of April," Isaac says.

Isaac is extremely thankful for the staff, volunteers, and donors who have stepped up tremendously during this pandemic. With the help of the community, Inland Valley Hope Partners will continue to keep our doors open for everyone who is in need!

- Verification of Income (e.g. Check Stub, most recent CALWORKS – notice action letter, Social Security or SSI award letter).
- Current Proof of address (e.g. mail with your name, address and postmarked within the last 30 days).

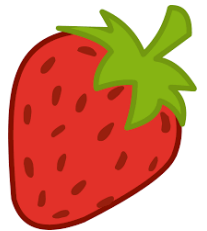
