A SINGLE HOMELESS PERSON CAN COME ONCE EVERY TWO WEEKS, AND RECEIVE A HOMELESS PACK. NON-HOMELESS FAMILIES AND INDIVIDUALS CAN RECEIVE USDA COMMODITIES AND OTHER FOOD SUPPLIES ONCE EVERY 30 DAYS.
