Hope Partners to Re-Open the Beta Food Pantry in Pomona! Your Help Needed!

This spring, Inland Valley Hope Partners was deeply saddened to close the Beta Food Pantry, a cornerstone of our mission since 1979. For more than four decades, the Beta Center has

provided food, compassion, and stability for thousands of Pomona families in need.

Today, we are delighted to announce plans to reopen the Beta Food Security Center—right here in Pomona! The new pantry will be located at First Christian Church, Pomona, on the same campus as our administrative and housing offices, and at the highly visible corner of Garey and Park Avenues. With its proximity to Pomona Valley Hospital, convenient access to public transportation, and our longstanding partnership with the church—dating back more than 50 years—this

site offers an ideal opportunity to create a lasting home for the Beta

Center and strengthen our service to the community.

Before we can open in this new location, the 1,000-square-foot space requires essential renovations. Plans include installing a new exterior entrance to ensure the safety of children in the on-site daycare, removing a few non-load-bearing walls for greater efficiency, and adding new flooring, paint, and finishing touches to create a welcoming environment. Altogether, these improvements are expected to cost approximately \$20,000 and can be completed within a month.

Your generosity will help restore a lifeline for families facing food insecurity. While \$20,000 may seem like a significant goal, together we can make it achievable:

- 20 donors at \$1,000 each
- 40 donors at \$500 each
- 80 donors at \$250 each
- 200 donors at \$100 each
- 400 donors at \$50 each

Every contribution—large or small—moves us one step closer to reopening this vital community resource.

Who We Are ...

Celebrating over 50 years of commitment, Inland Valley Hope Partners serves over 75,000 men, women and children each year through "Our House" family residential shelter; and Rapid Re-Housing; SOVA, Claremont and San Dimas food pantries; and the Pomona Farmers' Market throughout 13 communities including Chino, Chino Hills, Claremont, Diamond Bar, La Verne, Montclair, Mt. Baldy, Ontario, Pomona, Rancho Cucamonga, San Dimas, Upland, and Walnut. The

shelter houses five families for up to 90 days. The food pantries distribute five days worth of food per person to no and low income families. Clients may come once every 30 days. The Farmers Market operates every Saturday morning and accepts WIC and EBT cards. Begun in 1968 as the Pomona Council of Churches, today the non-profit is a collaboration of faith communities, businesses, community groups, and individuals who care about their neighbors.

Blessings ...

Our Rapid Re-Housing (RRH) Program assists families experiencing homelessness by helping them obtain employment, find appropriate housing, and then providing move-in costs, medium to short-term rental assistance and other resources to help them stabilize and maintain the housing long-term. But, some of our biggest obstacles in assisting these families is often finding both reasonably-priced rentals and property managers willing to rent to them due to their housing barriers.



This month I wanted to use my blessings piece to let you know that we are on the hunt for property managers and landlords in San Bernardino County to partner with us to help these families get back on their feet. Consider just a few of the benefits to landlords participating in the Hope Partners RRH program:

- **Decrease your advertising costs** We have ready-to-rent tenants for your vacant units.
- Timely and reliable payments while participants are in the program Hope Partners assists families with security deposits and other up-front moving costs as well as time-limited rental assistance. This allows clients time to stabilize and build an emergency fund for the future.
- **Problem prevention** We educate our clients on becoming ideal tenants and work with them on an ongoing basis to make sure they have the support they need to avoid past mistakes and become successful at independent living.
- **Neutral party to mediate problems** We are also here to support our landlords and offer back-up via a highly credible intermediary who can be called and will step in if/ when trouble or situations occur.
- Finally, the satisfaction of helping families in-need Everyone deserves a safe and affordable place to live. Some people make mistakes, but everyone deserves a second chance. By helping house our clients, you are playing an integral role in helping individuals take charge of their lives and making your community a better place to live.


Thank You for Walking for Hope at the Walk for the Hungry and Homeless

Housing Program Success Story

When Patty* came to Inland Valley Hope
Partners, she was facing some of the most
difficult challenges of her life. At 50 years old,
newly divorced, and without the support of
family, she was struggling to rebuild after years of
trauma, disappointment, and loss of trust in those
around her. With nowhere to turn and little faith
that her situation could change, Patty felt
completely alone.

But just when she thought all doors had closed, a new opportunity opened. After completing a phone screening, Patty was placed on the waiting list for Inland Valley Hope Partners' *Our House* Family Shelter. Only two days later, she received the call that would change everything: Hope Partners had an opening for her to come in for an interview. Exhausted, discouraged, and with no safe place left to stay, Patty says this felt like a miracle. "It finally felt like there's some kind of hope for me," she shared. And honestly, a spot in the shelter rarely opens up that quickly, so perhaps there was some divine intervention in her placement.

From that moment, Patty began a new chapter. With the support of Hope Partners' housing team, she was connected with resources, referrals, and guidance to help her find employment and begin planning for a stable future. Even more, when Patty was ready to move into an apartment of her own, we were able to pay her security deposit and first two months of rent through our limited state-funded HHAP Rapid Re-Housing Program — a major step toward lasting stability!

Today, Patty has renewed hope and a vision for her future. While she knows there is still a long road ahead, she no longer feels she is walking alone. She expressed her gratitude, saying, "Finally someone wanted to listen and join me in helping me find my way back. Hope Partners has given me a new beginning and a real start on life."

Congratulations, Patty, we are so proud of you and pray continued blessings for your future.
