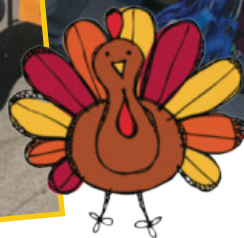




## Hope Partners Celebrates Thanks-GIVING!

**Who We Are ...**

*Celebrating over 50 years of commitment, Inland Valley Hope Partners serves over 75,000 men, women and children each year through "Our House" family residential shelter; and Rapid Re-Housing; BETA, SOVA, Claremont, San Dimas and South Pomona food pantries; and the Pomona Farmers' Market throughout 13 communities including Chino, Chino Hills, Claremont, Diamond Bar, La Verne, Montclair, Mt. Baldy, Ontario, Pomona, Rancho Cucamonga, San Dimas, Upland, and Walnut. The shelter houses five families for up to 90 days. The food pantries distribute five days worth of food per person to no and low income families. Clients may come once every 30 days. The Farmers Market operates every Saturday morning and accepts WIC and EBT cards. Begun in 1968 as the Pomona Council of Churches, today the non-profit is a collaboration of faith communities, businesses, community groups, and individuals who care about their neighbors.*

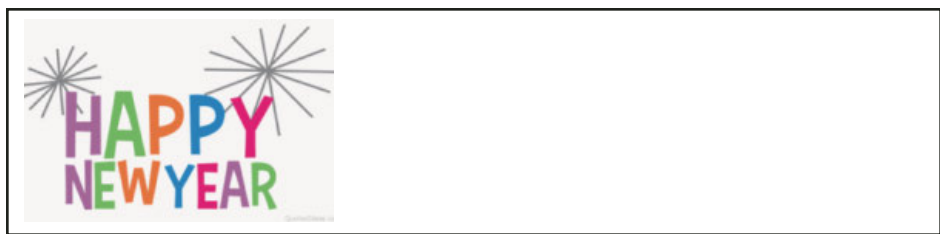
